General Instructions

Proposers must submit sealed Proposals in the form specified in this Request for Proposal (RFP) with any information required by this RFP by the time and date specified. The following instructions by the Edgewood Independent School District (hereafter known as the District) are intended to afford all Proposers an equal opportunity to participate in the RFP. Any explanation desired by the Proposer regarding the meaning or interpretation of these instructions or any other RFP document must be requested in writing from the District.

Specifications

Proposers are expected to examine the specifications, standard provisions, and all instructions. Failure to do so will be at the Proposer's risk. Submissions that include service specifications or provisions different from the services requested by the District may not be considered as responsive proposals unless written authorization is obtained from the District prior to submitting the Proposal. A copy of the authorizations must be included with the Proposal. The Proposers shall abide by and comply with the true intent of the specifications and not take advantage of any unintentional errors or omissions.

Invitation

The District is inviting competitive sealed Proposals for Network Infrastructure Upgrades.

Proposals will be received until Monday, March 18, 2019 at 2:00 PM.

Proposal received after the time and date specified will not be considered.

Bids will be opened on Monday, March 18, 2019 at 3:00 PM. Bid opening will be conducted in the District Conference Center in the Edgewood ISD Technology Building located at 1930 Herbert Ln, San Antonio, TX 78227. All interested parties are invited to attend the bid opening.

Submittal of Proposals

Proposals shall be delivered or mailed with any required data. Use an opaque, sealed envelope, container or box. Outside of envelope should indicate "E-Rate 2019", as the proposal name being submitted and date due, along with the name and address of the company submitting proposal. Submit Proposals to:

Sealed proposals must be submitted in sufficient time to be received and time-stamped at the above location on **or before 2:00 PM, Monday, March 18, 2019. Electronic Proposals (Faxed or E-Mailed) will not be accepted.**

Form of Proposals

Hard copy and a soft copy sealed proposals must be submitted in order to be considered by the District.

Proposers are welcome to attach additional material to fully detail the Proposal.

- Bidders will submit line/category labor pricing, clearly identifying which part(s) of the RFP for which the bidder wishes to be considered
- Acceptance of proposals, execution of contracts and implementation of any or all of the components of this RFP is contingent upon funding by the Universal Service fund and/or Edgewood ISD
- Vendor will provide a point of contact (POC) who will respond to questions following proposal submission
- Vendor will provide a brief (one page) summary of the company's background, including an outline of qualifications
- Vendors ARE required to attend an on-site visit to be held on Friday, February 22, 2019, 8:30 AM. The meeting location will be at 1930 Herbert Ln, San Antonio, TX 78227. Visit our website <https://www.eisd.net/Page/35040> for additional information.
- Vendor will supply Edgewood ISD with the company's USAC/FCC "Red Light" history
- Edgewood ISD requires a Certificate of Insurance greater than, or equal to one hundred thousand (\$100,000) dollars. In addition, Edgewood ISD requires that the vendor submit a document as proof of coverage by Workers Compensation for the State of Texas
- Edgewood ISD requires a performance bond in the amount of bid from the successful bidder(s) on this project
- Vendor will provide a minimum of three (3) projects of similar scope (or larger) that the Edgewood ISD can visit to verify their ability to fulfill the requirements of this RFP
- Vendor shall submit current certifications and qualifications demonstrating technical ability to install and test their proposed systems and subsystems
- Vendor will provide on-site people who are dependable, free of substance abuse, safety conscious, technically qualified and able to work well with other on-site contractors as well as Edgewood ISD personnel
- Vendor will ensure that no employee to be working at a school site is in violation of the State of Texas Sex Offender Laws
- Vendor will NOT use subcontractors unless approved by Edgewood ISD
- Vendor will provide a quality assurance plan for this project
- Vendor will provide a safety plan for this project
- Vendor will provide a project timeline for this project

Proposal Longevity

No Proposer may withdraw or cancel a Proposal for a period of sixty (60) days following the closing time for acceptance, nor shall the successful Proposer withdraw, cancel or modify the proposal after having been notified that the Proposal has been accepted by the District, except at the request of the District or with the District's consent.

Evaluation of Proposals

Proposals will be judged upon the Proposer's ability to provide services. The District reserves the right to make such investigations as it deems necessary to determine the ability of the Proposer to provide services meeting a satisfactory level of performance in accordance with the District's requirements. Proposers shall furnish such information and data for this purpose as the District may request. Interviews and presentations by one, several, or all of the Proposers may be requested by evaluators if deemed necessary to fully understand and compare the Proposer's capabilities and qualifications. Service Providers will be selected based on a Bid Evaluation as directed by the Schools and Libraries Programs and will include the following criteria;

1. E-Rate Eligible Purchase Price (primary factor). The E-rate program rules require that the E-rate eligible cost be the highest weighted factor in the bid evaluation and scoring process.
2. The reputation of the vendor and of the vendor's goods and services.
3. The quality of the vendor's goods or services.
4. The extent to which the goods or services meet the District's needs.
5. The vendor's past relationship with the District.
6. The impact on the ability of the District to comply with laws relating to historically underutilized businesses.
7. The total long-term cost to the District to acquire the goods or services.
8. Any other relevant factor specifically listed in this RFP.

District Prerogatives

The District reserves the right to award to the responsible Proposer whose proposal is judged to offer the most advantages to the District, with the District being the sole judge thereof; to negotiate with any or all Proposers; to reject any or all proposals, in whole or in any part thereof, and to re-solicit for proposals in such an event; and to waive any minor technicalities or informalities in accordance with the District's determination of its own best interests.

Proposer's Conditions

Any conditions or exceptions on the part of the Proposer for performance by the District must be set forth in the Proposal. The District is not obligated to consider the Proposer's post-submittal terms and conditions.

Venue

The agreement resulting here-from must contain language stating that the Request for Proposal is performable in Bexar County, Texas, and shall be construed in accordance with the laws of the State of Texas; if any legal action is brought in connection with enforcement of the Request for Proposal, exclusive venue shall lie in Bexar County, Texas.

Proposer's Preparation Costs

It shall be clearly understood that any costs incurred by the Proposer in responding to the Request for Proposal is at the Proposer's own risk and expense as a cost of doing business, and the District is not liable for reimbursement to the Proposer for any expense so incurred, regardless of whether or not the Proposal is accepted.

Inquiry

Any inquires or requests for explanation in regard to the District's requirements should be made promptly.

Prospective proposers desiring further information or interpretations must make requests prior to the Proposal Due Date and Time in order for a response to be issued to all prospective Proposers well in advance of the date for the submittal of proposals. Answers to all inquiries or requests involving substantive matters will be given to all Proposers of record and such information will be taken into account in the preparation of proposals.

Reservation of Rights:

The District expressly reserves the right to:

1. Reject or cancel any or all Proposals;
2. Waive any defect, irregularity or informality in any Proposal or Proposal procedure;
3. Waive as an informality, minor deviation from specifications as identified in the REQUEST FOR PROPOSAL if it is determined that the District's Project(s) is (are) improved or not impaired;
4. Extend the Proposal opening time and date;
5. Reissue a Proposal invitation.

Confidential Information

Bidders are advised that materials contained in their proposals are subject to the Public Information Act and may be viewed and/or copied by any member of the public, including news agencies and competitors. Edgewood ISD reserves the right to reject any or all proposals received, or to award a contract on the basis of initial offers received without discussions or clarifications. Therefore, the proposal should contain the vendor's best price and technical response based on the RFP.

Termination

The District shall have the right to terminate for default all or part of its RFP if Proposer breaches any of the terms hereof or if Proposer becomes insolvent or files any petition in bankruptcy. Such right of termination is in addition to and not in lieu of any remedies the District may have in law or equity, specifically including but not limited to the right to sue for damages or demand specific performance. The District additionally has the right to terminate this RFP without cause by delivery to the Proposer of a "Notice of Termination" specifying the extent to which performance hereunder is terminated and the date upon which such termination becomes effective.

Scope of Work

Brands:

Brand names that are included in this proposal request are for descriptive purposes, to indicate the quality, design and utility desired. These specifications are not intended to restrict competition. Brands of equal make or type (equivalent) to those specified are acceptable unless otherwise indicated in this proposal request. Each proposer shall indicate the manufacturer's name and model number of the brands being proposed.

Or Equal:

Whenever any materials, apparatus, equipment of process is indicated or specified by patent or proprietary name and/or manufacturer, the name so indicated shall be deemed and constructed to be followed by the words, "or equivalent." If an "or equivalent" option is proposed, the proposer will specify what brand, grade, model, etc. of any proposed substitute. The proposer must also provide a specification sheet and picture of the proposed product. The proposer shall clearly state any differences on the proposal sheet, not on an attachment of any kind. Edgewood ISD shall determine if the substitution is an equal or greater product after reviewing these items.

Substitutions:

Substitutions of brands after the award are not allowed unless prior approval from Edgewood ISD has been received. Substitutions must be submitted to Edgewood ISD 30 days prior to substitution. If an item is purchased and later discovered not to meet the original specifications, the vendor shall assume all responsibility and make adjustments as required by the district.

Category Two Services

1. The District is seeking bids for the installation, configuration and testing of 48 Port distribution switches such as the Catalyst 9200 PoE+ Plus or equivalent.
 - a. All switchgear bids should include all the necessary installation and configuration, auxiliary equipment, cabling and software needed to successfully use the equipment such as stacking modules, patch cables, fiber connection equipment such as SFPs, and licenses.
2. The District needs a CISCO 8500 Series Wireless Controller or equivalent with licensing to support 500 LWAPS. It is the District's preference that the existing access points be compatible with the proposed Wireless Controller.

3. The District is seeking bids for the purchase, installation, and configuration of at least 50 Light Weight Access Points such as CISCO 2802 or equivalent.
 - a. Bids should include all necessary auxiliary equipment and software such as mounting clips and licenses required to successfully implement and use the APs.
4. Bids should include installation and configuration of devices. Network cabling is required for this bid. The District is requiring the network drop, and all other accessories related to the proposed network devices. Access points will be installed on existing cabling.
5. One (1) Firewall or equivalent needed to support the school district; support for an estimated 13,000 devices.
6. Twenty (20) - APC Uninterrupted Power Supplies or equivalent with 208V, 110V Step Down Transformers

Bids should include a separate section for each campus.
