






#### **AP Students Enrolled by Grade Fall 2019**






#### **Dual Credit Student Enrollment by Grade Fall 2019**



## Reinforcement

#### College, Career, and Military Readiness (CCMR)

- Met 2021 Texas Success Initiative (TSI) goal of 22% in 2019
- Met 2019 Advanced Placement (AP) goal of 10 % at 11%
- Increased enrollment in AP courses with 173 more students
- Increased enrollment in Dual Credit courses with 140 more students
- Provide supports for students enrolled in Dual Credit courses
- Train Advanced Placement and Dual Credit teachers



### Refinement

#### College, Career, and Military Readiness (CCMR)

- Implement Texas Success Initiative (TSI) screeners for Math, Reading and Writing in 8<sup>th</sup> grade
- Develop a process to certify and recruit Dual Credit teachers
- Align Career and Technical Education programs from K-12th grade
- Develop industry partnerships to provide real-world application
- Adjust course offerings to align to standards and industry certifications exams





- New Advanced Placement (AP) and Gifted & Talented Instructional





## Reinforcement

#### **High Need Schools**

- 2019 Accountability the District and 6 campuses increased in overall score from 2018.
- CCMR scores improved in both District and high schools.
- Memorial HS had gain of 21-points for a score of an 80 or a "B".
- Edgewood ISD had a gain of 15-points for a score of a 78 or a "C".
- JF Kennedy HS had a gain of 11-points for a score of 76 or a "C".
- Gus Garcia MS had a gain of 4-points for a score of a 63 or a "D".

#### **Teacher Retention**

- Met 5-year goal to reduce teacher turnover rate with 18.1 %
- 3% salary increase for all employees and 3.5% increase for teachers with 6+ years
- 1<sup>st</sup> and 2<sup>nd</sup> year teachers received a \$150 gift certificate for classroom supplies

## Refinement

#### **High Need Schools**

- Nine (9) schools scored below a 60 or an "F".
- Ten (10) schools experienced a decrease in overall score from 2018.
- Wrenn MS received an overall score of 67, but due to the three (3) "F" rule, received a 59 or "F" despite receiving a higher score.
- Two (2) schools will open a new school model in 2020-2021.
- Two (2) schools will open a new school model in 2021-2022.

#### **Teacher Retention**

• District turn over rate of 18.1%, exceeds the state average of 16.6%.

### **Superintendent Evaluation**

#### **High Need Schools**

- 2019 District Accountability rating of 78 or a "C"
- 2019 CCMR Scaled Score of 83 Met the 5-Year District CCMR Goal of 82
- Three (3) high schools identified with distinctions
- Two new schools of Innovation: Gardendale PK4SA Early Learning Program and Brentwood STEAM School of Innovation
- Principal from Las Palmas and Perales are currently in incubation to launch an innovation school in August 2020

#### **Teacher Retention**

- Met 5-year goal to reduce teacher turnover rate with 18.1 %
- 3% salary increase for all employees and 3.5% increase for teachers with 6+ years
- 1<sup>st</sup> and 2<sup>nd</sup> year teachers received a \$150 gift certificate for classroom supplies
