
GPM 3.1 Texas Success Initiative








#### **GPM 3.2 Advanced Placement**



## Superintendent's Evaluation



### Goal 3: College, Career, and Military Readiness (CCMR) Accountability

- All data is based on the previous year graduates.
- The 2023 CCMR scores are based on the Class of 2022
- The 2024 CCMR scores are based on the Class of 2023
- TEA changed the score for a "C" from a 60 to 64 and changed the score for an "A" from a 90 to an 88.

### **GPM 3.1 - Texas Success Initiative**

• Class of 2023: TSIA, SAT and ACT tests not all completed, College Prep classes end in May 2023

### GPM 3.2 - Advance Placement

- AP scores arrive July 2023 GPM 3.3 - Dual Course Credits
- Dual credit courses end in May 2023
- **GPM 3.4 Industry Based Certification** 
  - 2023 Accountability changes Students must complete a level 2 CTE course which end in May 2023
  - Certain CTE courses do not allow students to test until they turn 18, end of the year or after they graduate.
