

### **Board Monthly Cadence**

<u>Board Workshop</u>: Workshop can last 4 to 6 hours. Our board learns about items that will be presented at the regular board meeting for approval. They can take a deeper dive and ask questions about the items to make a decision to approve or deny at the regular board meeting. May 30, 2023

**Board 1-1 Meetings:** Each board member meets with the Superintendent 1 to 1. Meetings are between the workshop and board meetings to allow the board member to ask the Superintendent clarifying questions.

<u>Board Performance Planning Meetings:</u> These meetings are being designed to bring attention to the Metrics associated with sustaining a High-Quality School District. Topics may be around areas of inventory in warehouse material, vehicle fleets, bus ridership, student participation in Nutritional programs, and Accounting audit findings, and updates on projects. Furthermore, analysis will consist of expounding on student assessment data, scholarship awards, enrollment in AP/ECHS/Dual Credit courses.

Board Meetings: Meetings can be between 2 to 3 hours long. These are held once a month. It is at these meetings that Board of Trustees approve all items on our Consent Agenda, if they believe it is in the best interest of the district. June 6, 2023

## LEGISLATIVE SESSION

SINE DIE

- calls for about \$33 billion in general revenue and \$63.5 billion in all funds for public education under the Texas Education Agency for the 2024-25 biennium
- It is important to note that \$8.5 billion of 2024-25 funding is dedicated to property tax relief through school district tax rate compression over the next biennium
- The upcoming budget also anticipates \$9.32 billion in recapture payments from local school districts compared to \$5.65 billion anticipated in SB 1 last biennium.
- While there was \$4 billion set aside for school funding and teacher compensation increases, <u>no</u> <u>legislation passed</u> that would have enacted that funding.

# HB 1

#### The State Budget bill



- includes the requirement that districts have at least one armed security officer per campus, but a school board may claim a good cause exception due to the lack of funding or available personnel. Those claiming a good cause exemption must develop an alternative standard that may include a school marshal or other armed staff member.
- increases the school safety allotment 28 cents to \$10 per student and includes a \$15,000 percampus allotment.
- HB 3 also requires most staff to complete mental health training; requires education service centers to serve as school safety resources for districts; and assigns TEA to monitor the implementation and operation of requirements related to school safety.

## HB3 School Safety Bill



 allows school districts to employ or allow volunteer chaplains to perform the duties of school counselors.
