- Presenter:
  - David Saldana
- Presentation goes over Public Health Programming for students such as Health Education, Child Nutrition, Physical Education, Family Engagement, Counseling & social services. Other topics include obesity & diabetes being overrepresented in Mexican Americas & African Americans.
  - Chief of Staff Olga Moucoulis: We received emails from individuals requesting to show this presentation again for more information & to be able to ask more questions.
- Questions:
  - Community member: How are the students in the unit being taught these components?

Mr. Salazar: All students should be taught this in the classroom & exposed to these components. It is typically taught in P.E. class or even in their science class.

Coach Benavidez: All students need 50% MVPA (moderate to vigorous physical activity)

Child Nutrition Director: It is a very engaging class. I have seen it being taught in the past few years here in Edgewood & the students love it & enjoy it.

- Community member: Have we had infractions with Community partners? Mr. Salazar: Yes, SA Food Bank is one of them. We are working with more partners to get funds for programming. P.E., Health, Arts are all being cut at the State level.
- Community member: Are there educational programs like this that can be directed to the campus? We have been trying to recruit students and parents to go to the camps to raise awareness about diabetes. How can I as a community member get these students involved?

Mr. Saldana: There is not enough awareness. The State is making it very difficult to raise awareness when they're cutting programs like health class & PE. The best way to do this is to better communicate with school programs like Family Engagement & health literacy.

Nurse Alaniz: Contact me. Region 20 sends me information on summer camps. We have a recruiter from Region 20 that I can contact. Email me directly so I can get that information for you.
